1. Kanti Children's Hospital, Maharajgunj, Kathmandu *invites electronic bids form eligible bidders for the procurement of* Modular Operation Theatre and OT Complex with Doctor's Lounge *under National Competitive Bidding- Single Stage Two Envelope* procedures.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit Simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.

5. Pre-bid meeting shall be held on 2080-1-10 at 1:00 PM at Kanti Children's Hospital, Maharajgunj, Kathmandu.
6. Electronic bids must be submitted to the office Kanti Children's Hospital, Kathmandu, *Maharajgunj, Kathmandu* by through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00** on **2080-01-17**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 2080-01-17** at the office of **Kanti Children's Hospital, Maharajgunj, Kathmandu** Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 20,69,755.00, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
